## Conditions of Entry

- › Companies may nominate a maximum of one individual/team per sub-category
- › Entrants must be WRIQ members (or in the case of a team category the industry partner must be a WRIQ member)
- › One or more signed references from authoritative sources, such as the nominee's manager or company chief executive/general manager must accompany the nomination
- › Entries must be accompanied by a high quality, electronic photograph that can be used for publicity purposes
- › Nominations must be received by WRIQ no later than the closing date. However, late entries may be accepted at the discretion of the Judges
- › It is at the judge's discretion whether to award a winner for each category.
- › All personnel, projects and initiatives nominated for an award must be based in Queensland.



### Driver of the Year

**This award recognises the outstanding performance of a professional truck driver, including driving skill, attitude and contribution to industry improvement**

#### Eligibility

This award is open to any individual who works in the waste and resource recovery industry in Queensland as a truck driver. Nominees should have demonstrated a continued high level of performance, initiative and all-round attention to detail in the execution of their duties.

#### Selection Criteria

- > A commendable driving record with a demonstrated focus on safety
- > A high degree of pride in their personal presentation and their vehicle's presentation.
- > A committed attitude towards their job, their customers and the industry as a whole
- > A strong interest in furthering the professional image of the industry, as demonstrated by their actions and interests
- > A dedication to the job through professional standards, client and supplier relationships, coaching, mentoring and training and demonstration of a safe workplace culture

## Trainee or Apprentice of the Year

**This award is presented to an individual who is undertaking a traineeship or apprenticeship and has been outstanding in all aspects of their training**

### Eligibility

The individual must be enrolled in a training course that leads to a nationally recognised outcome or qualification and must be enrolled or have completed their training in the period 1 July – 30 June 2026.

### Selection Criteria

- > An energetic attitude towards their job and the industry as a whole
- > A strong interest in enhancing the image of the industry, as demonstrated by their actions and interests
- > Be considered to have significant potential for further development in their chosen career path or similar work environment
- > Demonstrates a strong commitment to workplace culture and safety

### Plant/Equipment Operator of the Year

**This award recognises excellent performance, initiative and all-round attention to detail of a plant/equipment operator**

#### Eligibility

This award is open to any individual who works in the waste and resource recovery industry in Queensland as a plant or equipment operator (excluding trucks). Nominees should have demonstrated a continued high level of performance, initiative and all-round attention to detail in the execution of their duties.

#### Selection Criteria

- > An exemplary operating record with a demonstrated focus on safety
- > A professional attitude towards their job and the industry as a whole
- > A strong interest in furthering the professional image of the industry, as demonstrated by their actions and interests
- > A dedication to the job through professional standards, client and supplier relationships, coaching, mentoring and training and demonstration of a safe workplace culture

## Maintenance Employee of the Year

**This award celebrates the knowledge and expertise of the individuals who work behind the scenes in the industry's plant, equipment and vehicle workshops**

### Eligibility

This award is open to any individual who works in the waste and resource recovery industry in Queensland as a workshop manager/supervisor, mechanic or provide support within the maintenance field for plant, equipment and vehicles. Nominees should have demonstrated a continued high level of performance, initiative and all-round attention to detail in the execution of their duties.

### Selection Criteria

- > Please provide details demonstrating the nominee's high level of skill and aptitude demonstrated by - impeccable maintenance application, maintenance records and technical ability, relevant qualifications, innovative projects, safety and environmental initiatives that have produced tangible benefits for the employer company
- > A dedication to the job through professional standards, client and supplier relationships, coaching, mentoring and training and demonstration of a safe workplace culture

This award is open to any individual who works in a recycling/resource recovery facility in Queensland). Nominees should have demonstrated a continued high level of performance, initiative and all-round attention to detail in the execution of their duties.

#### Selection Criteria

- > An exemplary operating record with a demonstrated focus on safety
- > A professional attitude towards their job and the industry as a whole
- > A strong interest in furthering the professional image of the industry, as demonstrated by their actions and interests
- > A dedication to the job through professional standards, client and supplier relationships, coaching, mentoring and training and demonstration of a safe workplace culture

## Industry Professional of the Year

### Eligibility

This award is open to any individual who works in the waste and resource recovery industry in Queensland in an administration role. Nominees should have demonstrated a continued high level of performance, initiative and all-round attention to detail in the execution of their duties.

### Selection Criteria

- > An enthusiastic attitude towards their job, their customers and the industry as a whole
- > A strong interest in furthering the image of the industry, as demonstrated by their actions and interests
- > Demonstrated clear business improvement within their role
- > A dedication to the job through professional standards, client and supplier relationships, coaching, mentoring and training and demonstration of a safe workplace culture
- > Demonstrated improvement to safety culture, quality and business systems

### Lithium Battery Fire Hero of the Year

**This award recognises an individual who has demonstrated safe and effective intervention in controlling and/or preventing a lithium battery fire to safeguard a facility, vehicle, or workers.**

#### Eligibility

This award is open to any individual who works in the waste and resource recovery industry in Queensland. Nominees must have demonstrated outstanding judgement, initiative, and a strong commitment to safety in responding to a lithium battery fire incident or high-risk event.

#### Selection Criteria

- › An exemplary operating record with a demonstrated focus on safety
- › A professional attitude towards their job and the industry as a whole, including the ability to remain calm and act decisively under pressure
- › Demonstrated initiative, quick thinking and safe intervention in controlling and/or preventing a lithium battery fire to protect people, facilities, vehicles or equipment
- › A dedication to the job through professional standards, coaching, mentoring and training, and the promotion of a safe workplace culture and improved lithium battery safety awareness

## Industry Collaboration of the Year

**This award recognises councils, industry and partnership teams that have successfully implemented innovative initiatives, policies or programs advancing resource recovery (including organics processing) in Queensland. It celebrates collaboration between councils, industry, generators and end users to deliver shared outcomes. Examples include, but are not limited to, increased recycling participation, new collection systems, targeted awareness campaigns, and innovative use of resources or materials.**

### Eligibility

- › Open to local government and industry, including council–industry partnerships, industry–end user, and industry–generator collaborations.
- › The nominated program must be an ongoing initiative and meet all regulatory standards.

### Selection Criteria

- › Describe facilities, methodologies or programs, and provide data to quantify the impact and success of their work.
- › Provide evidence of the levels of recycling/diversion achieved
- › Demonstrated focus on quality, volumes and communications.
- › Development of new programs, facilities or equipment that will lead to safer or more efficient operations.
- › Entries must demonstrate how partnership and collaboration with another entity, or the general public, resulted in a meaningful and quantifiable sustainability outcome or breakthrough.
- › A dedication to professional standards, client and supplier relationships, coaching, mentoring and training and promoting a healthy and safe workplace culture

- › Open to industry and local government; industry and end-users, industry and generators or other partnerships
- › The nominated innovation must be an ongoing initiative and meet all regulatory standards

### Selection Criteria

- › Describe the innovative technologies, methodologies, or programs implemented
- › Provide data to quantify the impact and success achieved through the initiatives.
- › Present evidence of scalability and replicability of the innovation in other settings or regions.
- › Highlight any partnerships or collaborations with other entities or the general public that have enhanced the impact of the innovation.
- › Provide testimonials or case studies from stakeholders or beneficiaries to illustrate the impact of the innovation.
- › A dedication to professional standards, client and supplier relationships, coaching, mentoring and training and promoting a healthy and safe workplace culture

## Safety Innovation of the Year

**This award recognises excellence in developing and implementing an innovative solution to an identified health and safety issue. Entries for this award may include a product solution, an engineering innovation, a training program, an awareness raising activity or other risk control measures that reduce the risk of work-related injury and illness**

### Eligibility

- > Open to industry and local government; industry and end-users, industry and generators or other partnerships
- > The nominated program must be an ongoing initiative and meet all regulatory standards

### Selection Criteria

- > Describe the development of new programs, facilities, or equipment to address a specific health and safety issue in the workplace.
- > Demonstrate the effectiveness of the solution in reducing the risk of work-related injury and illness through measures such as reduced accident rates, improved safety records, or decreased absenteeism.
- > Showcase effective communication strategies utilised to promote safety awareness and engagement among employees, contractors and other stakeholders.
- > Provide examples of how the safety innovation has had a positive impact on employee engagement, morale, and overall well-being.

#### Eligibility

- › Open to industry and local government; industry and end-users, industry and generators or other partnerships
- › The nominated product must meet all regulatory standards

#### Selection Criteria

- › Describe the product and its use including its composition, specifying the percentage of recycled material it contains.
- › Demonstrate how the product's lifecycle and environmental impact have been considered, including the production processes, packaging, and transport.
- › Provide data to quantify the performance, usability, and durability of the product in fulfilling its intended purpose.
- › Highlight the potential for the product to be easily scaled, replicated, and adopted by a broad consumer base or industry and the accessibility and affordability of the product for various markets and demographics.
- › Provide evidence or testimonials from users of the product
